POSITION DESCRIPTION

Under direct supervision, this position maintains attractive, sanitary, safe restroom and shelter facilities for patrons and staff while meeting the department maintenance standards. Custodial services will be at shelter houses, the campground, and stand-alone park restrooms located throughout Shawnee County. Position will also assist with snow removal. Communicates with Campground & Shelter Supervisor and Recreation Leader concerning supply inventory and reports necessary repairs. Performs other duties as required. This position is supervised by the Campground & Shelter Supervisor.

WORK PERFORMED

90% Daily Operations.

- Follows schedule of cleaning duties that may include the following:
- Unlocking and locking of shelters and restrooms.
- Floors removed of trash, swept, vacuumed, and wet mopped.
- Cleans and sanitizes interior counters, tables, chairs, cabinets, sinks, vent hoods, appliances.
- Restrooms and shower houses cleaned, sanitized, and stocked, including toilets/urinals cleaned and scrubbed.
- Dusts and cleans ceiling fans, vent covers, window sills/frames, light covers, furnishings, and wall hangings.
- Cleans marks and blemishes on walls, floors and doors.
- Clean windows, mirrors, door viewing panes, and handles.
- Empties and cleans trash cans, replace bags, and dispose of trash in outside dumpsters.
- Cleans interior walls and baseboards. Removes staples, tape, glue and other decorations.
- Clean benches, picnic tables, grills, fireplaces and stock wood. Pickups trash and debris surrounding facilities and remove cobwebs and insect nests.
- Use powerwasher to clean open-air facilities and bathrooms.
- Uses blower to remove leaves, grass clippings, and snow when applicable. Keeps vehicles clean, fueled and stocked.
- Keeps shelter office, break rooms, pipe chases, and supply and storage closets clean and organized.
- **10%** Customer Service. Provides excellent customer service when showing shelters to interested renters and answering the shelter cell phone when renters call.
