#### POSITION DESCRIPTION

Under general supervision, this position is responsible for strengthening and expanding the Kansas Perinatal Community Collaborative (KPCC) model across the Shawnee County region. The Maternal Child Health (MCH) - KPCC Outreach Coordinator will be instrumental in improving maternal and infant health outcomes through coordinated community-based efforts. Performs other duties as required. This position is supervised by the Health Services Team Leader -MCH - Outreach.

This position is an Intermittent temporary, non-benefits eligible position. Intermittent positions are allowed to work up to 988 hours per year and may be ended prior to that without cause at Management's discretion.

#### **WORK PERFORMED**

- **Program Coordination.** Provides coordination with all agencies and community partners involved in select grant programs. Leads efforts to grow and strengthen KPCC infrastructure, drive strategic engagement with clinical providers, employers, and faith-based organizations, and expand the integration of not only the prenatal education program, Becoming a Mom® (BaM) curriculum, but also other relevant perinatal initiatives identified through local data and community input. Ensures communication channels with grant partners. Presents information and reports to community partners as required. Collaborates with other health and social service agencies in the community.
- **Program Management.** Develops, coordinates, implements and evaluates the work in order to ensure long-term sustainability. Leads the collaborative team, working closely with staff and subcontractors, to implement and apply various key measures. Collects, maintains and manages data related to health outcomes. Researches and promotes best practices related to improving maternal and infant outcomes.
- **25%** Outreach Activities. Builds partnerships with clinical providers to improve referral pathways, prenatal care access, and coordinated service delivery. Engages employers to highlight the economic benefits of improved maternal-child health. Collaborates with faith-based organizations to reach disparity populations and expand social and community support networks. Includes traveling to offsite locations as well as flexible scheduling of

events to accommodate requests from the public. Serves as liaison to outreach area providers and partner organizations to ensure increased program participation.

**10% Program Analysis and Reporting.** Ensures monthly and quarterly reports are submitted per grant requirements. Analyzes these reports for accuracy and adherence to grant standards. Compiles and analyzes program information and submits grant reports according to agreed-upon schedules. Establishes outcome measures and monitors compliance.
