POSITION DESCRIPTION

Under general supervision, this position works to control and eradicate noxious weed populations within Shawnee County borders. This position operates pesticide application equipment and uses cultural control methods in some locations. May be required to operate chemical sales counter and assists customers with herbicide questions. Performs other duties as assigned. This position is supervised by the Weed Director.

WORK PERFORMED

- **40% Equipment Operation.** Operates computers, vehicles, roadside sprayer, forklift, herbicide application equipment, small tools and machinery.
- **40%** Responsible for Fulfilling Contracts. Responsible for the noxious weed control for right-of-way and contract areas of Shawnee County.
- **Public Relations.** Establishes and maintains effective working relationships with the public.
- **Equipment Maintenance.** Maintains, troubleshoots and repairs pesticide equipment and makes purchases for maintenance and repair of equipment.
- **Customer Service.** Operates the sales counter and point-of-sale register as needed. Assists customers with herbicide and eradication questions.
- **Inventory Control.** Assists in managing inventory control, stocking chemicals and products, packaging orders, and managing herbicide inventory used for applicator usage.
