POSITION DESCRIPTION

Performs skilled/manual work functions related to maintenance and operation of the Parks & Recreation Department sports facilities. Responsible for daily preparation of sports complexes for league, practice and tournament play. Assists with annual and routine maintenance of all aspects of facility operations and structure. Serves as the onsite staff for special events assigned by supervisors and evaluated on cleanliness of such facilities. Supervised by Sports Maintenance Technician and Sports Field Manager.

This position is an Intermittent seasonal, non-benefits eligible position. Intermittent seasonal positions are limited to working only the parks season (February to October) and may not exceed 1,100 hours of work in the season. Intermittent positions may be ended prior to that without cause at Management's discretion.

WORK PERFORMED.

70% General Maintenance/Field Prep. Prepares sports fields for practice, league and tournament play. Carries out a year-round sports field maintenance program of sports fields. Establishes and maintains sports field turf, performs janitorial/custodial duties and performs a variety of tasks in the operation and maintenance of the sports division.

20% Customer Service. Provides customer service by responding to requests from the general public, providing information, and directing customers to appropriate individuals.

10% Other Duties as Assigned.
