**POSITION DESCRIPTION**

Performs basic facility, aquatic park maintenance repairs and improvements, aquatic facility mowing and weed eating and assists with projects. Assists with pool chemicals, cleaning debris from spray pads, and clean-up of vandalism and graffiti. Duties include basic grounds maintenance and improvements. Performs other duties as assigned. This position is supervised by the Park Maintenance Leadworker under general supervision of the Aquatics Supervisor.

This position is an Intermittent seasonal, non-benefits eligible position. Intermittent seasonal positions are limited to working only the parks season (March to November) and may not exceed 1,100 hours of work in the season. Intermittent positions may be ended prior to that without cause at Management's discretion.

**WORK PERFORMED.**

**70% General Maintenance.** Duties include mowing grass; operating a weed eater; water chemistry, basic aquatic facility maintenance, and general construction projects.

**20% Customer Service.** Provides customer service by responding to requests from the general public, providing information, and directing customers to appropriate individuals.

**10% Other Duties as Assigned.**
