POSITION DESCRIPTION

Under general supervision, this position operates a variety of construction equipment to repair and maintain roads and signs. Performs other duties as required. This position is supervised by the Assistant Road Supervisor.

WORK PERFORMED

- **80%** Routine Maintenance. Operates all road and traffic maintenance equipment, including the operation of a dump truck, spreading material, the motor grader in cutting and grading ditches, cleaning ditches, finish grade leveling and blade patching, mowing and weed eating, snow removal and blading, painting, sign maintenance and installation.
- **10%** Chip Sealing. Operates the asphalt distributor, including being able to read the gauges for set-up of spraying asphalt, as well as knowing the maintenance of the machine, including servicing after use. Operates the chip spreader.
- **5% Paving.** Operates the lay down machine, including clean up after use.
- **5% Reporting.** Fills out time, labor and equipment sheets and must have full knowledge of work orders and feature numbers pertaining to work done.
