POSITION DESCRIPTION

Under general supervision, this position will collect solid waste as a member of a solid waste collection crew. Performs various manual tasks at Rolling Meadows and the shop, as assigned. Learns to operate the packer controls of a solid waste truck. Responsible for understanding and following safe operations procedures, work rules and county/department policies and procedures. Performs other duties as required. This position is supervised by the Solid Waste Collection Supervisor.
